The exhibitor, who is named on the application (including staff associated with the exhibitor), must attend the tables reserved in his/her name, and is responsible for following the show rules of conduct including federal and local regulations. Show staff and Security can at any time remove you and your belongings if found in violation of regulations, and at no refund to you. Exhibitor passes are issued by table. One table will have two passes; with a max of 5 passes. The exhibitor pass will allow the owner entrance to the venue one hour and 15 min before the start of the show, each day. The pass must be worn and visible at all times during the show. While the MWCA recognizes the need for some exhibitors to break down prior to the close of the show, we ask that you remain in place the entire show hours as a courtesy to the paying public. Table rules on back. No subletting of tables. No sales to anyone under the age of 18 unless permitted by parent or guardian. No animals allowed other than service animals. Electrical services may come at an additional charge, based on facility. Tables must be claimed by 8:00am Saturday of the show or will be forfeited and revert back to the MWCA. To qualify for a refund on tables cancelled, exhibitor must cancel the Monday prior to public openings of the show. The MWCA is not responsible for any lost or stolen items. The Executive Director and the MWCA Board of Directors has the discretionary power to remove unacceptable items from sales and display tables.
